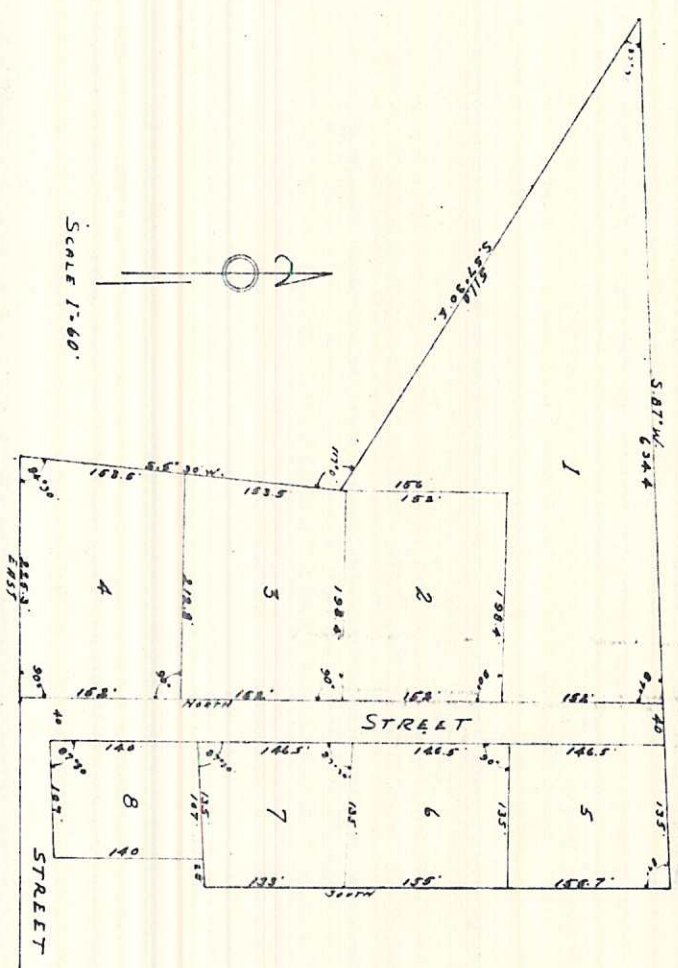




SE Cor. SW 1/4 OF 32-2-2W
