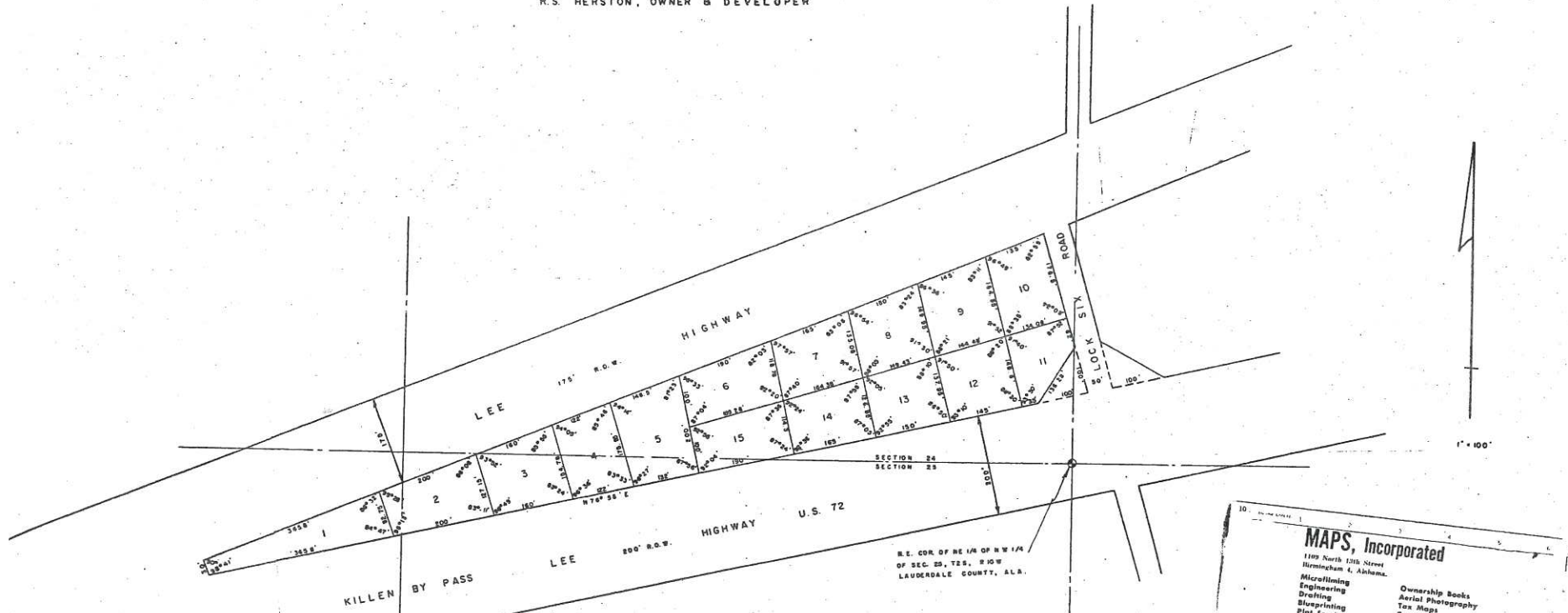

The streets and public roads and alleys shown hereon for electric, telephone, water, gas and sewer services and for such services, rights of way ten feet wide on either side of each side and rear lot line and other rights of way as shown conveying the privileges necessary for the installation and maintenance of such utilities over the respective rights of way including the right to cut and clear trees or parts thereof or other objects that may injure or endanger overhead lines except that no easement is granted on the late side of any lot and the said city shall have no easement along any side lot line when said line is not a boundary line between two co-terminus land owners.
